In an effort to continue promotion of quality improvement for services provided to WellCare of New Jersey, WellCare, and Ambetter from WellCare of New Jersey's members, effective **July 1, 2023**, WellCare of New Jersey, WellCare, and Ambetter from WellCare of New Jersey are expanding their existing partnerships with National Imaging Associates, Inc. (NIA). This program includes prior authorization for non-emergent MSK procedures including outpatient, interventional spine pain management services (IPM) specific to spinal cord stimulators; inpatient and outpatient hip, knee, shoulder, lumbar and cervical spine surgeries for WellCare New Jersey Medicaid, Medicare, and Exchange members. This decision is consistent with industry-wide efforts to ensure clinically appropriate quality of care and to manage the increasing utilization of these services.
